Introduction

Thank you for taking the time to read through this guidance which contains important information you will need to help you decide whether your organisation and project are eligible and suitable for Biffa Award Partnership Grants Scheme funding.

Grants of between £250,000 and £1,000,000 are available, and although there is no limit on the total cost of your project, preference will be given to those where Biffa Award is recognised as a majority funder.

We strongly recommend that you only submit an Expression of Interest (EOI) when your project is in a position to start work, as we will expect the project to start once a Formal Offer Agreement has been issued in February or May 2027.

The Scheme remains highly competitive and receives a far higher number of applications than we can fund. 2025 saw the submission of 42 EOI applications with nine invited forward to full application. Even if your submission qualifies for funding, it may still be rejected if the Board feel that it would not compete against others.

Unfortunately, village halls, community centres, local authorities, hospices, hospitals, day-care centres, rehabilitation units, residential care facilities, allotment sites, schools/colleges, activity centres, youth clubs and places of worship are excluded from making an application to the Partnership Grants Scheme.

We are unable to support projects in Scotland and Wales.



Our Themes

Built Environment

An Expression of Interest submitted under this theme should aim to restore, modernise and improve cultural, heritage or visitor facilities.

Grant applications for exhibitions, interpretation and interactive displays, including design costs, are welcomed, as are applications for new visitor centres, education spaces, walking trails and associated facilities.

You will need to demonstrate regional or national significance, how the facility will be inclusive and how it will inspire learning, creativity and participation amongst tourists and day visitors.

Facilities must be open to the general public for a published period of at least 104 days each year, and you should consider environmental sustainability throughout.

We are unable to provide funding towards staff costs or volunteer costs related to the management of any part of the project.



The project should not cross over two themes.

Natural Environment

For submissions under Natural Environment, we are looking for projects that seek to support, protect and restore a variety of living things, their habitats and the natural processes that support them.

Projects should deliver commitments set out in your country's [Environmental Improvement Plan](#), legally-binding targets from the Environment Act 2021 or priorities identified within Local Nature Recovery Strategies.

Grants to cover the purchase of land to protect it in perpetuity, to create or extend an ecosystem, or to secure vital habitats for the future, promoting nature's recovery, are welcome.

Additionally, we encourage applications to help nature reserves and natural spaces adapt to climate change, for example: habitat management work to improve fire breaks and access for fire services to tackle wildfires; installing dams to manage water flow; and providing shade for wildlife.

Day rate equivalent costs for staff undertaking direct delivery work in relation to the project, or supervising volunteers in project delivery tasks can be funded, but only if this demonstrates better value for money than using external contractors to deliver the same work.

We are unable to provide funding for habitat improvement work on land where the applicant plans to sell biodiversity units. However, we can purchase land that an applicant will improve for the purpose of selling biodiversity units.



The project should not cross over two themes.

Submission Deadlines

The purpose of the Expression of Interest (stage one) is to allow an initial assessment of the project by the Biffa Award Board. Each submission is closely assessed against our eligibility criteria and the priorities of the scheme, to enable identification of those projects that are most likely to be funded.

There is no limit to the number of Expressions of Interest an organisation can submit. However, we will only invite one application per organisation to submit a Full Application.

As the completion of a Full Application (stage two) requires a significant commitment, resource and effort, including the production of a short film, we do not wish to invite an applicant to make a Full Application if we feel they are unlikely to be successful.

If invited to submit a stage two Full Application, you will need to upload quotations and competitive tender documents to support project costs, as per regulatory guidelines: One recent quotation for any single items costing up to £1,000; three recent quotations for any single items or works costing more than £1,000 and up to £25,000; and evidence of competitive tendering where project costs exceed £25,001.

Submission of Expression of Interest deadline: **5pm, 29 May 2026**

Outcome of Expression of Interest submission: **Late August 2026**

Stage Two (dependent award confirmation date)

Submission of Full Application: **5pm, 25 September 2026**

Outcome of Full Application: **Mid-December 2026/Mid-February 2027**

If Successful (dependent on award confirmation date)

Work to commence: **February/May 2027**

First Claim due: **May/August 2027**

Project completion: **February/May 2028**



Is the organisation and project eligible

The organisation must be a fully constituted, charitable or not-for-profit organisation with no share capital. Unfortunately, local authorities, hospices, hospitals, day-care centres, rehabilitation units, residential care facilities, allotment sites, schools/colleges, activity centres and youth clubs are not eligible to make an application through the Biffa Award scheme.

The project must be eligible for registration with the scheme's regulator, Entrust, and must meet the following criteria:

- Application value must be between £250,000 - £1,000,000
- The project site must be within 25 miles of a significant Biffa Operation or active Biffa Landfill Site (please refer to the postcode checker for this fund on the Biffa Award website and copy the address as you will need it to complete your application)
- The project site must **also** be within 10 miles of a licenced landfill site (please click [here](#) to check eligibility and copy the address as you will need it to complete your application)
- A Third Party Contributor to fund 10% of the application value should be identified (this could come from your own reserves if you are not a registered Environmental Body with the scheme's regulator, Entrust)
- The project must not cross the two themes
- All shortfall funding must be secured
- Work must start in February/May 2027 and complete within one year
- **Natural Environment** projects should support your country's Environmental Improvement Plan, any legally-binding targets from the Environment Act 2021, or priorities identified within a Local Nature Recovery Strategies
- Minimum of 104 days of published and full public access each year
- Any Biffa Award grant must be used for site-based improvement work, not for movable equipment, staff core costs or storage facilities
- Red Book Valuation at stage two will be required for any land purchase applications under the **Natural Environment** theme
- Planning permission and or licences to undertake any work must have been granted prior to the submission of an Expression of Interest
- If the organisation does not own the project site a fully signed lease with at least 25 years remaining must be in place for Built Environment applications. We cannot accept any other forms of agreement, including but not limited to draft agreements, letters of intent, heads of terms, subleases or underleases
- A fully signed landowner agreement, giving permission to access the site for maintenance, surveying and monitoring for at least 25 years post completion of the project must be in place between the landowner and applicant for **Natural Environment** projects, if the applicant does not own the land

You cannot re-apply for funding on the same site of a previous Biffa Award grant within one year of receiving your final payment.

What we look for in an application

Your application should showcase creativity, innovation and environmental sustainability. You should consider ways to mitigate the impact of your project both during project delivery and after funded works are complete, for example by employing local tradespeople, using sustainable materials, recycling existing components, reducing energy consumption or reducing carbon footprint.

As well as answering some general questions through our online grants application portal, you will be asked to outline your project in no more than 1,000 words, provide relevant project designs and visualisations, and submit up to 10 relevant photographs, where possible.

Remember, the scheme is extremely competitive, so this is your opportunity to sell your project to us. Be concise but provide as much relevant detail as you can across all sections of the form, working within any word limits.

Built Environment

Your project outline should tell us how the project will transform, restore, modernise and improve your cultural, heritage or visitor centre.

Outline any plans for ambitious, interactive and exciting interpretation. Demonstrate its regional or national significance, and how will it be inclusive of a diversity of potential beneficiaries. Your plan should also include how will it promote learning, creativity and participation.

Don't forget to include details of any volunteer involvement, partnership working and your published opening hours.

Natural Environment

Your project should outline how the project will restore, improve, and transform the natural environment and provide details about its regional, national or international significance.

You will be asked to provide a comprehensive biodiversity management plan and list of species and/or habitats the project will introduce, conserve and/or protect, as well as information on public access and volunteering opportunities.

Don't forget to include details on any wider partnership plans for the project.

Work that we cannot fund

Unfortunately, we are unable to fund some items. This is a list of some of the most common things that we receive requests for but which we must decline. The list is not exhaustive, so if you are in doubt, please contact us by email at biffa-award@wildlifetrusts.org so that we can advise you.

Previously funded Built Environment projects

Biffa Award is proud to have funded some truly inspirational and innovative Built Environment projects over the last seven years. From STEM experiences at science centres and captivating aquariums, to immersive memorials, and spaces designed to foster creativity, learning and participation.

Supported by £1 million in funding, the Royal Botanic Gardens, Kew developed the groundbreaking Carbon Garden—an interactive space that brings the story of carbon and the scale of the climate emergency to life. It encourages visitors to leave inspired, informed, and ready to take action for nature and the climate.



With £418,550 of support, The Deep in Hull has unveiled a collection of immersive new exhibits. Visitors can dive into interactive STEM activities, get creative at crafting and water-play stations, encounter high-tech jellyfish and plankton displays, and explore a vivid audio-visual journey along the East Yorkshire shoreline - making the experience unforgettable for audiences of all ages.



Supported by £700,000 in funding, the International Bomber Command Museum in Lincoln has developed a series of compelling interactive and immersive exhibits, complemented by a peaceful commemorative garden that pays tribute to the men and women who served in Bomber Command during the Second World War.



With £390,784 of support, The Customs House in South Shields has transformed its auditorium with new retractable seating, creating a flexible and dynamic space. The addition of immersive and interactive theatre experiences, along with a vibrant participation hub, is enabling the organisation to deliver rich cultural programmes that deepen community engagement.



Previously funded Natural Environment projects

Biffa Award is proud to have funded numerous Natural Environment projects that have a meaningful impact on nature conservation and the recovery of biodiversity. Our projects have reintroduced beavers to Britain, created rich pollinator habitats, and secured land in perpetuity for nature's recovery.

With £964,419 of support, Coronation Meadows - backed by King Charles III – has helped start a nationwide revival of wildflower meadows. So far 90 vibrant new meadows have been created, covering over 1,000 acres and thriving with pollinators.



Supported by a £923,831 grant, Knapdale Forest enabled the return of wild beavers - over 424 years after they were hunted to extinction. These natural engineers are now helping to create wetlands, revive woodlands and support a rich diversity of wildlife.



With £750,000 of support, the Woodland Trust has been able to secure the remaining two thirds of Yonder Oak Wood, Exeter securing it in perpetuity for the benefit of nature's recovery. In ownership, the site will provide a matrix of habitats that will enhance biodiversity, bio abundance and landscape connectivity, whilst also offering recreational green space to the public.



Supported by £671,113 of funding, Lancashire Wildlife Trust was able to purchase and restore Rindle Moss, a key component in reconnecting the once vast lowland raised peat bogs of Chat Moss. Restoration, planting and rewetting have set the stage for a vibrant ecological recovery, with rare species now returning to the landscape.



About us



Biffa Award is managed by the Royal Society of Wildlife Trusts (RSWT). As well as operating as an umbrella group for the 46 local Wildlife Trusts that have been formed across the UK, RSWT has a dedicated grants team that manages several different funds, covering a number of broad environmental themes.



Biffa Award money comes from Landfill Tax Credits, reclaimed from the Government through the Landfill Communities Fund (LCF). The scheme is regulated by Entrust, which ensures that the tax credit is awarded and managed according to Government regulations.



Entrust is the HMRC appointed regulator of the Landfill Communities Fund. All projects are registered with the regulator to ensure funding is spent in line with Government approved objects. All projects, except for some existing Environmental Bodies (EB), are registered by RSWT.

Third Party Contribution

You can apply to Biffa Award for up to 100 per cent of the project costs. However, under LCF regulations, only 90 per cent of any grant can be paid by us using Landfill Tax Credits. The remaining 10 per cent needs to be provided by another source, either from your own general reserves (if you are not a registered EB) or from an independent source (if you are a registered EB). 10 per cent will be paid directly to Biffa Group Limited, on request, if your application is successful.

Third Party Contributions are different to match or shortfall funding and are non-refundable.

If you are already enrolled with Entrust as an Environmental Body, you must follow specific rules around the Contributing Third Party which can be found on the Entrust website at: www.entrust.org.uk.

We may revise the amount of funding available and make changes to our published criteria, as well as updating the list of significant Biffa Operations at any time. Where possible we aim to give three months' notice.
